

PRIVACY POLICY

Recognizing the importance of personal information provided by customers (hereinafter referred to as "Customer Personal Information"), we, PT. Bintang Utama Sentosa, manage this information as described below to handle it properly.

- 1. Purpose of using personal information
 - We use Customer Personal Information only to the extent necessary to achieve the following purposes. We will not use Customer Personal Information for any other purpose without the prior consent of the customer..
 - To provide our products and services to customers
 - To provide information about our products and services to customers
 - For research and development leading to new products and services.
- 2. Provision of personal information to third parties
 - We will not, except as permitted by law, provide Customer Personal Information to third parties without the customer's prior consent.
- 3. Security control measures
 - We will take measures to keep Customer Personal Information accurate and up-to-date, and to prevent unauthorized access to Customer Personal Information, as well as loss, damage, falsification, or leakage.
- 4. Appointing another party to handle Customer Personal
 In the event that we appoint another party to handle Customer Personal Information, we will
 require the appointed party to take appropriate security control measures in accordance
 with the contract, and we will supervise the appointed party properly and as necessary.
- 5. Shared use of personal information
 - We will use Customer Personal Information together as set out below, within the scope of the purposes of such joint use as set out below.
 - Personal data that can be shared.

 - Purpose for the co-user:
 - To provide products and services related to our business and information about those products and services to customers, and for research and development of new products and services.
 - Name or title of the person responsible for controlling personal data used with PT.

Please note that in responding to such requests for disclosure, etc., we may require the customer to present documentation confirming their identity (driver's license, passport, etc.).
